



Privacy Statement of the chess club Alphense Schaakclub (A.S.C.)

1. Introduction

The chess club Alphense Schaakclub (A.S.C.) (the "**Association**") is the administrator of the website www.alphenseschaakclub.nl. This overview indicates how the Association collects personal data and how this data is used. The responsible party for the processing is the Association.

The Association is committed to protecting the privacy of its members and visitors to its website. Personal data of members and visitors are processed and secured with the utmost care. The Association complies with the law and regulations in the field of the protection of personal data, such as the Personal Data Protection Act and – with effect from 25 May 2018 – the General Data Protection Regulation (GDPR / AVG).

Where applicable, you consent to the use of your information as described in this privacy statement whenever you use the Association's services. We recommend that you read this document carefully and contact us if you have any questions.

2. What data is collected?

General data relating to visits to the Association's website is collected without identifying the visitors. This data also includes the **IP address of the visitor**. The IP address is a number that is automatically assigned to the computer when the Internet is started. The IP address is not linked to the identifiable data of the visitor, unless explicit permission has been obtained for this.

Personal data is collected by the Association for the purposes stated below. This information is available to the Association because you have entered your details yourself on the relevant registration form of the Association, when registering for training sessions, competitions and tournaments, sometimes when creating an account or otherwise. This data usually concerns your **identity and contact details** (such as: name and address details, date of birth, gender, telephone numbers, e-mail address and registration date of membership). Special personal data within the meaning of the GDPR are *not* collected.

Payment information is collected by the Association for the purposes listed below. This information is available to the Association because you have entered your information yourself when paying the membership fee and for training and tournaments. This data contains very limited payment details, such as the date of payment and method of payment.

3. How are the personal data used?

The Association processes your personal data for the following **purposes**:

- fulfilling the objectives of the Association, including but not limited to
 1. to be able to contact you
 2. to send you information
 3. organizing chess matches
 4. keeping track of results and standings
 5. facilitating and promoting participation in chess matches and chess tournaments
 6. to communicate with you about your account if applicable
- keeping a membership administration;
- calculating, recording and collecting contributions and/or registration fees;
- complying with legal obligations.

4. To whom are the personal data provided?

Your personal data will be provided or shared with the umbrella regional chess association and the Royal Dutch Chess Association ("**KNSB**").

In addition, the Association provides the KNSB with match results for the rating processing.

If you no longer wish to receive e-mails regarding the activities and news of the Association, you can use the **unsubscribe option** that is included in every e-mail that the Association sends.

No commercial use

The Association will not sell, rent, distribute or otherwise make your personal data commercially available to third parties without your prior consent.

Correctness of the personal data provided

By communicating your personal data, you guarantee that these are **correct and complete**. When communicating false identities, incomplete or incorrect data, the Association can temporarily or permanently deny you access to the websites or parts thereof.

Retention of personal data

The Association does not store personal data for longer than necessary for the realization of the purposes for which the data is processed, and in any case for as long as is required by law.

5. How are the personal data secured?

The Association always takes appropriate technical and organizational measures to protect your personal data against loss, unauthorized access, misuse, unwanted disclosure or against any form of unlawful processing.

For example, a limited number of employees have access to the Association's website, this access is secured with a login procedure, firewall and security software, the software is regularly updated and the data is regularly backed up.

If you feel that your data is not properly secured or there are indications of misuse, please contact the secretary of the Association. In the event that the Association discovers unauthorized access to your data, the Association will notify you immediately and notify the appropriate authorities if required by law.

6. Links to other websites, products and services of third parties

The Association's website may contain references and/or advertisements to websites, products and services of other organizations or companies. The Association is not responsible for the use of your personal data by those other organizations or companies. This privacy statement only relates to data collected by the Association. The Association advises you to consult the privacy policy of the relevant organizations or companies before using their websites, products or services.

The advertisements on the Association's website may use **cookies**. These cookies are created by the organizations or companies responsible for the advertisements. The Association is not responsible or liable for these cookies.

The Association also registers and processes personal data on the association section of the Online Members Administration of the Royal Dutch Chess Association (KNSB OLA), www.ola.schaakbond.nl. A limited number of employees of the Association have access to this website and this access is secured with a login procedure.

7. Your privacy rights

You have the following rights:

- the right to **request access** to your personal data
- the right to request **correction, restriction or deletion** of your personal data
- the right to request the **transfer** of your data (This means that you can submit a request to the secretariat of the Association for the personal data that the Association has about you in a computer file and to send this file to you or to another organization mentioned by you.)
- the right to **object to the use of your data**
- the right to **withdraw the processing of your data at any time** if this data processing is based on your consent
- the right to **submit a complaint** about the use of your data to the national supervisory authority, the Dutch Data Protection Authority (Autoriteit Persoonsgegevens)

You can send your requests and/or questions regarding privacy-related matters to the secretariat of the Association. You will receive an answer as soon as possible, in any case within 30 days.

If you have an account with the Association and close your account, the Association has no obligation to keep this information about you and we can delete it in whole or in part without any liability.

However, the Association may retain information if required by law or for legitimate purposes, such as: account recovery, auditing our records, or exercising our rights and obligations under our agreements.

8. Privacy Policy Changes

The board of the Association reserves the right to change the statement of this privacy policy, for example to keep up with new legal regulations. The Association expects most such changes to be minor. However, there may be instances where changes to the privacy statement are more significant. In such cases, the Association will prominently announce such changes before they become effective or directly notify you. Also check this privacy statement regularly to stay informed of the most recent version.

If you continue to use the services of the Association after the effective date of the most recent version of the privacy statement, this means that you agree to the amended privacy statement. If you do not agree to the revised privacy statement, please stop using our services and contact us to close any account you have created.
